The Earnest money of successful bidder deposited with the quotation shall be converted in to security deposit after successful allotment of work order and shall be released after successful completion of contract (i.e after 1 year). 12. The personnel so supplied by the contractor shall be fully outsourced and they shall have no right to claim the regular services in lieu of outsourced duty performed by them.
