Work has been planned as per MoM of joint meeting of TS (D), Grid Construction, P&M organization and Civil Works officers carried out on the DK-1 & DK-2 on dated 06-10-20233. Cap bank can be erected after dismantling of 220kV tower adjacent to 66kV bay.4. Estimated cost has been considered as per Cost Data 2022-23 as furnished by TS (D) office.5. The expenditure shall be charged to the head "Augmentation/Additions of T/fs at 220/132/ 66 kV S/Stns of PSTCL", Sr. No. 69 of Annexure-3 of MYT 2023-26 as per provision of Approved Capital Investment Plan for the control period 2023-26 Expenditure allocated upto March-24: Rs. 11.90 Crore. Expenditure already booked via amendments till date: 3.61 Crores Expenditure to be booked for this amendment: Rs. 3.61 Crores Balance expenditure for the control period: Rs. 4.68 Crores.6. This work shall be included in the transmission works for the FY 23-24.7. This work is subject to ratification by BoDs.
