The Boards of Directors in its 53rd meeting held on 08.03.2019 at VIP Guest House Mohali considered CE/HIS & D Agenda No. 09 dated 08.03.2019 and decided to adopt PSPCL Jt.Secy/Services-1 (Gaz-6) O/o No. 166 dated 11.10.2012 to the extent as under at under:-

1. Whenever an officer/official is posted at a place in the public interest indicating the same in posting order but his salary charged to another post, then he shall be paid the salary and allowance as applicable to the actual place of posting where he is working.
2. Whenever and officer/official is posted at a particular post in his own interest and the salary being charged to another post, CMD shall decide and allow the requisite allowance while issuing the transfer orders.
3. In future, officer/official shall work at a station only against the sanctioned posts otherwise approval of competent authority for creation/abolition of the posts shall be taken in advance before such postings.
4. Adoption mentioned at Sr. No. 1 above shall be applicable prospectively i.e. form the date of issue of this office order.
