Subject: - GSTIN of PSTCL and Purchase from Unregistered Dealer under GST.

Central Govt. has notified July 1<sup>st</sup>, 2017 to implement the Goods and Services Tax (GST). GST identification number (GSTIN) of PSTCL is 03AAFCP4714J1ZK (copy of Certificate of Provisional Registration is enclosed herewith).

While purchasing goods or availing services from registered dealer, it may be ensured that GSTIN of PSTCL <u>03AAFCP4714J1ZK</u> is mentioned in the invoice by the supplier, so that Input Tax Credit (if applicable) can be availed by the company & the purchases are reflected in the returns of GST.

Further as per section 9 (4) of CGST Act 2017, if any taxable goods or services or both is supplied by unregistered dealer (which is not registered under GST Act) to Registered dealer, then the receiver has to pay GST under Reverse charge Basis. According to above provision of the Act, PSTCL is liable to pay GST under Reverse charge on taxable goods or services or both received from unregistered dealer on or after 01.07.2017. Further PSTCL has to raise self-invoice of such supplies. In order to regulate such supplies competent authority has decided to issue instructions as under:-

1. All the offices of PSTCL shall ensure that purchases of taxable goods are made from persons registered under GST. Purchase of goods from unregistered person should be avoided, as in such cases the purchasing office shall have to

raise self-invoice of such purchases (for amount of GST) and purchaser is required to deposit GST under reverse charge basis. It is hereby clarified that person registered under GST under composition scheme shall be treated as registered

- 2. All offices of PSTCL should make earnest efforts to avail services from registered person only. In case of unavoidable circumstances only the services of unregistered persons be availed. However, In case of Advocates/CAs services can be availed as per prevailing practice and invoices of these services and invoice of other services received from unregistered person for amount of GST should be generated as shown in point 3 below.
- 3. In case services are availed from unregistered as per point no. 2, invoice as per rule 46 of CGST rules 2017 shall be generated by the concerned office and shall be reported to the office of AO/CPC, Patiala for deposit of GST and alongwith other applicable returns under GST Act at central level.
