
Sub:- Nomination for appointment to the position of Member, West Bengal Electricity Regulatory Commission.

Sir

The position of Member of West Bengal Electricity Regulatory Commission is lying vacant.

2. The Selection committee constituted under section 85 of the Electricity Act 2003 for the purpose of selection of Member of the Commission, has decided to seek nominations of suitable persons for this position, from all State Governments, Ministry of Power, CPSUs related to Power Sector and Department of Personnel and Training, Government of India.
3. Under the provisions of the Electricity Act, 2003, a Member of the Commission shall be a person of ability, integrity and standing who has adequate knowledge of the Act and has shown capacity in dealing with problems relating to engineering, finance, commerce, economics, law or management.
4. The Member shall hold the post for a term of 5(five) years from the date he/she joins the office or till he/she attains the age of 65 years, whichever is earlier, Further, the Member shall not hold any other office during this period.
5. The Member of the Commission is entitled to get a fixed pay as available to a Secretary/Principal Secretary, Government of West Bengal as applicable plus other allowances as per rules. The salary, allowances and other terms and conditions of service of the Member shall be governed by the West Bengal Electricity Regulatory Commission (Salary, Allowance and Conditions of Services of the Chairperson and other Members etc.) Rules, 2004 as amended from time to time.
6. I would request you to kindly forward nomination of suitable persons possessing requisite qualification and experience as prescribed in the Act, so as to reach us during working hours by Monday, 25TH April, 2017 along with two copies of CVs in prescribed format of the persons nominated (Format enclosed). Further, in respect of nominated persons in service, copies of their ACR Dossiers covering a period of the last 5(five) years may kindly be enclosed.
7. While sending such nominations, it may kindly be ensured that the person nominated does not have any financial or other interest which is likely to affect prejudicially his/her functions as Member of the West Bengal Electricity Regulatory Commission.

APPOINTMENT TO THE POST OF A MEMBER OF WEST BENGAL ELECTRICITY REGULATORY COMMISSION

Applications are invited from eligible persons for appointment to the position of a Member of the West Bengal Electricity Regulatory Commission. In terms of Section 84(1) of the Electricity Act, 2003, The Member of Commission shall be a person of ability, integrity and standing who has adequate knowledge and has shown capacity in dealing with problems relating to engineering, finance, commerce, economics, law or management. A person having any financial or other interest that is likely to affect prejudicially his/her function as a member of the commission is not eligible. In terms of section 89(1) of Electricity Act 2003, a member shall hold office for a term of five years from the date he/she joins the office or till he/she attains 65 years of age, whichever is earlier. The salary, allowances and other terms and conditions of service of the Member shall be governed by the West Bengal Electricity Regulatory Commission (Salary, Allowance and Conditions of Services of the Chairperson and other Members etc.) Rules, 2004 as amended. A Member is entitled to get same scale of pay as available to a Secretary/Principal Secretary, Government of West Bengal plus other allowances as admissible.
