Shifting of existing current accounts to New Variant.

Presently PSTCL is maintaining its current accounts with the State Bank of India for collection and payment purposes of DDO. Presently DDOs are required to maintain minimum balance for collection and payment accounts Rs 11000/- and Rs 12000/- respectively.

SBI has launched a new variant of current accounts exclusively for government departments, autonomous bodies and Statutory Bodies. New variant has special facilities like unlimited NEFT/RTGS at home branch, 10 cheques books of 50 leaves cheques each free of cost, zero minimum balance requirements, nil account keeping charges etc. The copy of the Circular has been attached herewith depicting salient features of new variant.

The currents accounts of PSTCL (Both Collection and payment purposes) are eligible for being shifted under new variant of current account. The competent authority of the PSTCL has desired to shift the current accounts under new variant.

DDOs are requested to compliance with the following instructions.

- All DDO are required to contact with home branch for shifting the both collection and payment account under new variant.
- As under new variant no minimum balance is required to be maintained.
 DDOs are required to transfer the minimum balances being maintained
 presently in their collection account to PSTCL's main collection account
 65082611137.

However, DDO needs to maintain Rs 1000/- as minimum balances in payment account to counter any situation like cheque return charges and transfer the balance amount to PSTCL's main collection account 65082611137.

 All other charges i.e. account keeping charges, RTGS/NEFT charges etc. have been waived off under the new variant. It is the sole responsibility of the DDOs to ensure the availment of such concession/ facilities.
