Estimated cost has been considered as informed by ASE/Grid construction division, PSTCL, Jalandhar vide his office memo No. 1595 dated 21.7.22 and ASE/Civil works division, PSTCL, Jalandhar vide memo No. 1327 dated 22.7.22.3. The expenditure shall be charged to the head "Additional 220/132/66 kV bays", Sr. No. 70 of MYT 2020-23 as per provision of Approved Capital Investment Plan for the year 2020-23. Expenditure allocated upto control period upto March 23: Rs. 28.85 Crore. Expenditure already booked via amendments till date: Rs. 15.59 crore. Expenditure to be booked for this amendment: Rs. 0.653 Crore (including EC & IDC). Balance expenditure for the control period 22-23: Rs. 12.607 Crore.4.
