



ELIGIBILITY PRE-CONDITIONS OF BIDDERS FOR OPENING OF PART-III

- a) Tender documents of only those firms shall be processed who full fill the following criteria and submit the sufficient proof of the same while uploading the tender.
- i) The contractor should give detail of truck/trailer in his possession. He should have a sufficient fleet of vehicles to ensure a minimum lifting capacity of 70 MT per day in normal course and up to 100MT of cement per day in case of exigencies.
- ii) The details of carrying capacity of each truck/ trailer be given separately along with regtn. No of vehicle.
- iii) Solvency/ Certificate from the scheduled bank.


Every tenderer shall produce along with his tender a solvency certificate from a schedule Bank. If he fails to produce such a certificate, his tender may not be considered. The details of solvency certificate requirement is as under:-

- a) The minimum amount of solvency certificate (in lacs) will be worked out by dividing, the tendered cost (in lacs) with completion period (in months) of work.
- b) The solvency certificate will be considered up to 1 year period from its issue to date of opening of tender.

- b) **Tender from contractors, who are black-listed or with whom business dealings are suspended by PSTCL shall be rejected.**
GENERAL CONDITIONS: -

- a) A set of tender documents containing technical specifications, general instructions, terms & conditions can be downloaded from official site of PSTCL.
- b) The tenderers shall be required to submit earnest money in the form of Bank Draft in favor of Sr. A.O./ CPC, PSTCL, Patiala, except in case of those tenderers who are specifically exempted.
- c) Incomplete and conditional tenders will not be accepted.
- d) The quantities can be increased or decreased and the firms shall have no claim on this account. Also the above quantity can be ordered on more than one supplier.
