

## DETAILED NOTICE INVITING TENDER

1. On line Tenders in the prescribed form as uploaded on website are hereby invited from the enlisted contactors for the work of Repair of damaged UC fencing, boundary wall and raising height of toe wall at 220kv s/s Banga
2. The tender documents can be down loaded from the website [www.eproc.punjab.gov](http://www.eproc.punjab.gov). EMD shall be deposited online.
3. Only e-tendering mode will be acceptable. The e-tender should be submitted through online mode on the website (<https://eproc.punjab.gov.in/nicgep/app>)” or [www.eproc.punjab.gov](http://www.eproc.punjab.gov))
4. Eligibility Criteria :  
To qualify for getting himself registered with [www.eproc.punjab.gov](http://www.eproc.punjab.gov), each bidder in its name should have achieved following mile stones: **For Tender enquiry no 53/2023-24**
  - (i) Experience of having successfully completed similar works during last 7 years ending last day of month previous to the month in which tenders are invited should be either of the following:
    - a. Three similar completed works costing not less than the amount equal to Rs 2.49 lacs.
    - b. Two similar completed works costing not less than the amount equal to Rs 3.12 lacs.
    - c. One similar completed works costing not less than the amount equal to Rs 4.98 lacs.Similar works means repair/construction of toe wall, boundary wall and construction of building.
5. The time allowed for completion of work will be Three Months after the date of issue of letter of intent or Allotment Letter to the firm whichever is earlier.
6. **Earnest Money:**  
The tenderers shall be required to submit 2% of tendered amount Minimum Rs 12500/- as Earnest Money through online.
7. The tenderer's EMD deposit (whose tender is accepted) will be converted into security and five percent security will be deducted from the running bills.
8. The rates shall be valid for a period of 120 days from the date of opening of the Tender. The earnest money shall be forfeited if the tenderer withdraws or modifies his offer within the validity period or fails to sign the (Formal Contract) agreement after acceptance of his offer or fails to commence the work within ten days of issue of acceptance letter. The earnest money will be forfeited.
9. On acceptance of the tender, the firm shall arrange the availability of an accredited representative, fully authorized in writing at the site of work to receive instructions of the Engineer-in-charge or his representative and to ensure prompt compliance thereof.
10. The Competent Authority does not bind itself to accept the lowest rate or any tender and reserves to itself, the right of accepting the whole or part of the tender and tenderer shall be bound to perform the same at the quoted rates.
11. Before filling the tender, the site shall be visited by the representative of the firm and satisfy itself as to the conditions prevalent there especially regarding accessibility to the site, nature and extent of the ground, working conditions, stacking of materials, installation of Tools and Plants etc. accommodation and movement of labour, supply of water and power for satisfactory completion of the works contract. No Claim, what so ever, on such account shall be entertained by the department in any circumstances.
12. The tenderer shall bear all costs associated with the preparation and submission of his tender and the department shall in no case be liable for these costs

13. GST applicable as per Govt. Norms.
14. Each tenderer shall submit only one tender, either by himself or as partner in a joint venture. A tenderer who submits or participates in more than one tender, will be disqualified.
15. Unless otherwise stated the contract shall be for the whole work as described in the "Schedule of items of works". The contractor shall be bound to complete the whole work as described in the schedule of items of works including the additional items if any, as per instructions. The certificate of completion as issued by the Engineer-in-Charge shall be the conclusive proof of completion of work.


