In continuation of this office memo no. 5843/48/General-497 Vol. II dated 24.04.2023 and memo no. 11493/98/Gen-497 Vol.-II dated 16.08.2023, following amendment is hereby made in the Corporate Transport Policy of PSTCL-2023: -

Clause No.	Existing Clause	Amended Clause	
Para 2(C)(iv)	The Work Order for out-sourcing of vehicles, for the vehicles not more than 4 years old, shall be initially for a period of one year and the same shall be extendable on year to year basis, for a further period of two years, subject to the performance of the Vehicle/Service Provider. Hence the maximum period for which a vehicle can be hired is 3 years. After a period of 3 years, a new tender needs to be floated.	The Work Order for out-sourcing of vehicles, for the vehicles not more than 5 years old, shall be initially for a period of one year and the same shall be extendable on year to year basis for a further period of three years, on the satisfactory performance of the vehicle/service provider subject to condition that the vehicle can continue in the department upto the 7 years of its life. Hence the maximum period for which a vehicle can be hired is 4 years. After a period of 4 years, a new tender needs to be floated.
