- 5. Earnest money shall be 2% of tender value with minimum of Rs.5000/- whichever is higher. Earnest money shall be nil for work order below Rs.50,000/- as per Works Regulations The tenders from the firm having permanent earnest money for Transmission works shall also be accepted providing a certificate to this regard is contained in the envelope containing earnest money.
- 6. The quoted rate should be valid for 120 days from the date of opening of tender.
