1. The tenderers' are required to submit tenders in two separate envelopes. The first envelope will contain deposit of earnest money and the second containing tender. The envelope containing the earnest money shall be opened first and if it is found in order then second envelope containing the tender shall be opened.
2. Bidder whose work order has been cancelled in the past due to unsatisfactory work, are not eligible to apply.
3. The rates should be valid for 120 days from the date of opening of tenders
4. T&C of Work Regulation 1997 Shall be applicable
5. Tenders received through telex/telegraphically or through fax shall not be accepted.
6. The undersigned reserved the right to cancel the quotation without mentioning any reason.
7. If the date of opening of tender happens to be holiday, quotations shall be received and opened at the same time of next working day.
8. Quotation should be shown Your Registration with PSTCL as work regulation Sr No. 05, Technical Availability, Financial Soundness and Experience in this Work field (if any).
9. Conditional tenders are liable to be rejected.
10. The quantity of work may be increased or decreased.
11. In case of work is not satisfactory a warning shall be issued. In case, if negligence still persists, the penalty will be charges at double of the rate on prorata basis.
12. 13. The Earnest money of successful bidder deposited with the quotation shall be converted in to security deposit after successful allotment of work order and shall be released after successful completion of contract (i.e after 1 year). Further, EMD shall be returned to unsuccessful bidder by this office after allocation of work order to ELIGIBLE bidder.
14. The personnel so supplied by the contractor shall be fully outsourced and they shall have no right to claim the regular services in lieu of outsourced duty performed by them.
15. The contractor will be responsible for any damage done to the building or other installation in the office complex.
16. Quotation should be shown Your Registration with Department of GST, ESI, EPF (if applicable)
17. The contractor should engage major (i.e age above 18 years) labour.
18. The contractor will engage labour which should be of good character and honest, hence he will be responsible for any theft on behalf of them.

21. If the contractor fails to carry out said work satisfactory his work order may be cancelled by undersigned at any time. His security and earnest money will stand forfeited.

25. The rate quoted by the agency shall be firm during the period of contract and shall be based on the DC rates.
26. The contractor has to enter into any agreement on a non-judicial stamp paper as per PSTCL rules within 15 Days of the award of contract. The cost of stamp and other documents/completion of formalities shall be borne by contract.
27. GST and other taxes will be applicable as per statutory law.
28. All Legal proceedings against this contract shall be in the jurisdiction of Civil Court at Jalandhar.
29. If at any time any question, Dispute of difference, what so-ever arise between the vendor and PSTCL, upon or in relation to, or in connection with the order/contract, he may go for arbitration clause contained in Work Regulation 1997, as amended from time to time.
