

- 5) The tenderers are required to submit tenders in two separate envelopes. First Containing all relevant documents like Copy of GST, PAN, Bank Detail, Authorized Dealer/Firm Certificate, Specification Sheets, if any etc. and the second containing tender quotation. The envelope containing the documents shall be opened first and if it is found in order then a second envelope containing the tender quotation shall be opened.
- 6) The envelopes must be super scribed with the name of tender and due date of opening of tender & marked as Part-1 "Documents" & Part-2 "Quotation".
- 7) The quotation should be complete in all respects; incomplete tenders or telegraphic tenders are liable to be rejected.
- 8) The office reserves the right to place an order for any item in full or part thereof indicated in this tender notice and to reject any or all tenders received without assigning any reason. SGST & CGST if any should indicate separately.
- 9) Material will be delivered to Consignee Authority within 30 days from receipt of PO. If the firm fails to deliver the material in stipulated period of Purchase order, the same is liable to be rejected and if accepted the firm will be liable to pay as penalty charges @ 0.5% of the cost of left over supply/work per week for the delay or thereof subject to maximum of 10% of the cost of complete unit of undelivered material.
