1. Prices

2. Validity

The offer shall be valid for at least 60 days from the date of tender opening and any modification of the offer shall not be permitted.

3. Work completion

Work shall be completed within 21 days from the date of issue of work order.

4. Insurance:

The rates are F.O.R destination and as such, it is the responsibility of the supplier to deliver the goods in sound condition F.O.R Destination and for this purpose, the supplier may at his option insure the material against all risks at his own cost during transit for full delivered value of the material up to destination.

5. Terms of Payment:

95% payment of contract value pro -rate basis against receipt of material in good condition /Refilling of equipment's (wherever applicable) (along with 100% taxes, duties, levies) as per the contract shall be paid within 45 days against receipted challan /Invoices and balance 5% amount of total bill excluding tax shall be releases after completion of warranty period .Payment will be made through RTGS only & firm shall provide Bank Account detail, IFSC code etc.

6. Invoicing:

The Invoices should be sent in quadruplicate to Sr. Xen. 400 Kv sub station Nakodar PSTCL with prior intimation. All the payments will be made by Sr. Xen. 400 Kv sub station Nakodar PSTCL .

7. Negligence and default

In case of negligence, failure to execute the order /contract with due diligence & expedition, the purchaser may blacklist or suspend business with the supplier under intimation to the all purchasing authorities of PSPCL /PSTCL.

8. Acceptance /rejection/cancellation of the quotation/offer

Conditional quotations shall be out rightly rejected. Further the purchaser reserves the right to accept /reject/cancel the quotation in full or in parts without citing any reason. 10 Penalties
