The envelope containing the documents shall be opened first and if it is found in order then a second envelope containing the tender quotation shall be opened.
- 6) The envelopes must be super scribed with the name of tender and due date of opening of tender & marked as Part-1 "Documents" & Part-2 "Quotation".
- 7) The quotation should be complete in all respects; incomplete tenders or telegraphic tenders are liable to be rejected.
- 8) The office reserves the right to place an order for any item in full or part thereof indicated in this tender notice and to reject any or all tenders received without assigning any reason. SGST & CGST if any should indicate separately.
- 9) Material will be delivered to Consignee Authority & installed within 30 days from receipt of PO.
