7. EMD shall be forfeited in case of withdrawal modification of an offer within the validity period.
8. The EMD/ Security submitted is liable to be forfeited, if the contractor fails to provide material as per terms and conditions of the purchase order.
9. All the rates should be quoted by contractor in ink writing without any overwriting/ cutting.
