Tender Specifications:-

- 1- The work shall be executed strictly as per PSTCL requirement, terms & conditions of the specification tender.
- 2- It is informed that in case tender process is not completed due to any reason, corrigendum will be uploaded only on PSTCL Website.
- 3- Contractor shall be held responsible for any kind of loss during the execution of work. Contractor is liable all precautionary measures for safety of men & material.
- 4- Before quoting the rates Tenderers should inspect the site and examined the conditions of HTLS Conductor wooden reels. The Bidder is advised to visit and examine the site of Works/Services and its surroundings and obtain for itself on its own responsibility all information that may be necessary for preparing the Bid and entering into a Contract for the required job. The costs of visiting the site shall be borne by the Bidder. The Bidder shall not be entitled to hold any claim against PSTCL for non-compliance due to lack of any kind of pre-requisite information as it is the sole responsibility of the Bidder to obtain all the necessary information with regard to site, surrounding, working conditions, weather etc. on its own before submission of the bid.
- 5- Prices quoted by the Bidder, shall remain firm and fixed and valid until completion of the Contract and will not be subject to variation on any account. Only "Firm" prices shall be accepted. Offer with ' Variable ' prices shall be rejected.
- 6- Contractor is fully responsible for any kind of damaged/loss to the material or property of PSTCL. Cost of damaged is to be recoverable from contractor.
- 7- Work will be executed inside the premises of store yard of AEE store Jamsher.
- 8- Work shall be executed by the authorized/experienced contractor through skilled labour.
- 9- All the tools & Plants/Machinery will be provided by the contractor. No machinery of PSTCL is allowed to be used by contractor.
- 10- Empty Ms Iron reels/Wooden reels of Zebra conductor will be provided by PSTCL at the site work i.e. at Store Jamsher. If any prior repair required for rewinding the same shall be done by contractor in store premises without any extra cost.

- 11- Gross weight & Net weight of the contractor drums should be measured in the presence of AEE store Jamsher.
- 12- 95% payment along with 100% GST and other statutory levies shall be released within 45 days after of work at site.
- 13- 5% security shall be deducted from the gross amount of running bills and shall be released after the expiry of defect liability period which is 6 months from the date of issue of completion certificate or payment of final bill whichever is later. No interest shall be payable to the contractor on amount of security deposit.
- 14- Completion of work- The work must be completed within 15 days from the date of issue of work order.
- 15- The PSEB works regulation 1997 shall form part of contract agreement.
- 16- Contractor shall execute a contract agreement on prescribed format as per Annexure-1 of PSEB work regulation 1977 within 10 days of issue of work order contract failing which no payment against work order shall be made and acceptance of this tender shall be cancelled and EMD shall be forfeited.
- 17- PSTCL is registered centrally in the state under GSTIN 03AAFPC4714J1ZK and firm shall be registered under GST.
- 18- Income tax/labour cess or any other taxes as applicable shall be deducted from bills.
- 19- The payment will be made as per work actually executed at site after observing all rules, regulations and statutory obligations.
- 20- Undersigned reserves the right to reject/alter/cancel any part or whole of the work without assigning any reason.
- 21- Penalty- If the work is not completed within scheduled time, the contractor shall pay as penalty and amount equal to 0.5% for every week subject to maximum of 10% of total cost of work.
- 22- All others terms & conditions of tenders shall also be applicable.
- 23- Jurisdiction- All legal proceedings in connection with the work order contract issued shall be subject to territorial jurisdiction of local civil courts at Patiala only.
- 24- Contractor shall be registered/enlisted with PSTCL, PSPCL erstwhile PSEB, PB PWD/B&R, MES, Railways as per Work Regulation and will submit registration certificate at the time of placing bid.
- 25- Rate shall be valid upto 30 days from the date of submission of quotation and any modification shall not be permitted.
- 26- PSTCL all general terms & Conditions/Regulations are applicable.
