## GENERAL TERMS & CONDITIONS

### **1.1 SUBMISSION OF TENDERER:**

Notwithstanding anything contained to the contrary in the specification of tenders or in the subsequent exchange of correspondence, these conditions of contract shall be binding on the contractor and any change or variation expressly approved by the competent authority. The contractor shall be deemed to have fully informed himself and to have special knowledge of the provisions of the conditions of contract here in contained.

Following instructions must be carefully observed by the Tenders. Quotations/ Tenders not strictly in accordance with these instructions will be liable to be rejected. Failure to comply with any of these instructions or to offer explanation for non-compliance is likely to render effective comparison of the tender as a whole impossible and may lead to rejection of an otherwise lower offer:

- i. Tender must be complete in all respect.
- ii. Telegraphic/ Telefax/ Telex quotations/ offers will not be accepted.
- iii. Earnest money/ tender fee and other relevant documents shall be received in the office of Addl. SE./ P&M Division, PSTCL, Dhandari Kalan on or before the due date/ time given in the tender notice and shall be opened in the presence of Tenders or their authorized representatives who may like to be present. In case the due date of opening of tenders happens to be a holiday, documents such as tender fee, earnest money etc. relating to tender shall be received and opened at the same time on the next working day.

### **1.2 TENDERS TO BE INVALIDATED:**

Tenders must be complete in all respect. Conditional, incomplete or not properly sealed tenders and tenders received late due to any reason whatsoever will be rejected.

### **1.3 INSPECTION OF SITE BY TENDERERS:**

Tenders should inspect the site and examine and obtain all information required and satisfy themselves regarding all matter and things before submission of their tender such as:

- i. Whether any existing access to the site available on the highway, its suitability for transporting equipment and extent of maintenance required keeping it into a serviceable condition.
- ii. The type & extent of access roads to be provided by the contractor including its maintenance for the transportation of equipment.
- iii. The type and number of equipment and facilities required for the satisfactory completion of work the quantities of various sections of the work, the availability of the local labor, availability and rates of materials, local working conditions, extreme weather conditions, uncertainty of weather, obstruction and hindrance that may arise etc. all which may affect the work or cost thereof.

### **1.4 SIGNING OF TENDER:**

Tender shall be signed by the owner or person holding power of attorney by him to do so. Necessary documents in support should be enclosed with the bid at the time of submission, failing which tender may not be considered.





**1.5 EARNEST MONEY:**

The Tenders shall be required to submit Earnest Money as per Rules & Regulations of PSTCL.

(a) Public Sector Undertakings fully owned by Punjab Govt./ Central Govt. or other State Govt.

(b) Entity registered under MSME

shall be exempted from depositing Earnest Money, provided that a certificate of Govt. Ownership shall be submitted in the envelop for EMD.

In case tender not accepted, the EMD will be refunded within 30 days of award of Order/ Contract to the unsuccessful Tenders after the expiry of additional period, whichever is later.

Following fixed rates (2% of cost of work or Rs. 5000/- minimum) in the form of Cash Receipt/ Bank draft, along with the tender in favor of **Addl. SE/ P&M Division, PSTCL, Dhandari Kalan**, Payable at Ludhiana.

**1.6 PRICE VARIATION:**

Quoted rates/ prices should preferably remain firm for the entire duration of contract.

**1.7 PAYMENT:**

Sub Station Wise payment will be made after deducting security and other taxes after completion of work.

**1.8 VALIDITY:**

The tender should be unconditionally valid for at least a period of 4 months (120 days) from the date of opening of the tender. Withdrawal or modification of the offer shall not be permitted. Any tender revising the offer within the validity period is likely to be black-listed. In case the firm is silent about validity the tenders will be assumed to be valid for 120 days from the date of opening of tenders.

**1.9 PERIOD OF CONTRACT:**

The work shall be completed within a period of Two Months from the date of WO. However, Addl. SE./ P&M Division, PSTCL, Dhandari Kalan reserves the right to terminate this agreement by giving 15 days advance notice without being liable to give any reason or pay any compensation.

**1.10 MISCELLANEOUS TERMS & CONDITIONS:**

- i. The contractor shall be fully responsible for any loss/damage to the property or any equipment, personnel or his own staff, caused due to any act of the workmen supplied by him.
- ii. The contractor shall not claim any compensation for any damage or loss resulting to him due to any act of God, riots, floods, earthquakes, etc. during the contract period.

All other terms and conditions shall be as per standard terms & conditions of PSTCL.
