- Any firm which are defaulter for the supply of 25% or more quantity of the ordered quantity for more than 09 months from the date of expiry of the contractual delivery period at the time of opening of the tender enquiry, shall be regarded as defaulter and shall not be eligible for participation in any new tender enquiry for a period of three years from the date of issue of purchase order in which it has defaulted. This clause shall be applicable item wise (all types sizes and ratings) against which the firm has become defaulter under the above said conditions. However, different voltage class will be considered as separate item.

- The purchaser reserves the right to reject any or all of the tenders received, without assigning any reason.
- The competent authority may distribute the quantity to be procured on one or more firms as per prevailing Purchase Regulation.
- Conditional tenders shall not be accepted.
- Quotations received by e-mail/fax will not be accepted except for proprietary items
