**EMD** Nil for tender value upto Rs. 50,000/- and for more than Rs. 50,000/- @ 2% of tender value (rounded off to a multiple of Rs. 10 on higher side), subject to the minimum of rupees 5000/- which ever is higher, in the shape of demand draft in favour of **Sr. Executive Engineer, 400 KV Substation PSTCL, payable at Rajpura** or NEFT.

**Terms & Conditions:**

- Telephonic, e-mailed, Fax and conditional quotations will not be entertained.
- The firm should have registered GST Number.
- If the quotations are not received in this office on time, then it will not be accepted.
- Tenders are invited from registered firms/Contractors which are registered with any of PSTCL/PSPCL/Power Grid Organization/PWD/MES/Railways and other such Central/State Govt. organizations.
- The Prices shall be of FOR destination at site.
- Approximately 74 Hrs. of work is required for year 2024-25 and 2025-26.
- The undersigned can increase/ decrease the quantity of work as per site requirements or cancel the quotations at anytime.
- The contract to the service provider will be upto 31.03.2026 and may be extended for further one more year after approval from competent authority.
- Payment will be made through NEFT by the O/o Addl. S.E./ 400 KV S/s, PSTCL, Rajpura on the basis of total hours of work done per cutting after verification of bills by AEE/Mtc. 400KV S/s, Rajpura.
- The Tractor with bush cutter/shrub master along with diesel and operator will be provided within one hour of telephonic intimation by AEE/Mtc., 400 kV S/s Rajpura or any representative of his office.
- The number of hours shall be counted after reaching the Tractor at site and up to completion of work as intimated by Engineer-In-charge.
- The firm/contractor may visit the O/o AEE/Mtc, 400 KV S/s, Rajpura on any working day/time before opening of tender for any clarification regarding work.
