

- The Tender documents cost is not charged as per Financial Advisor, PSTCL, Patiala (Budget Section) O/o No: 10 dt: 22-2-18 and Earnest Money need to be paid in the form of cash or Demand Draft drawn on any scheduled bank in the favour of Senior-executive-engineer-P&M Civil Maintenance Division, PSTCL, Jalandhar.
- Earnest money shall be 2% of tender value with minimum of Rs.5000/- whichever is higher. Earnest money shall be nil for work order below Rs.50,000/- as per Works Regulations. The Earnest Money along with Documents should be kept in envelope duly sealed super-scribed "EARNEST MONEY" and Quotation should be kept in separate envelope duly sealed super-scribed "QUOTATION".
- Quotations not accompanying the EMD as per sr. no. 2 will not be entertained.
- Tenders for part work, Conditional tenders, telegraphic tender through fax or tenders not on prescribed forms of tenders without earnest money in the required shape shall not be accepted.

9. If the work is not completed within stipulated period, PSTCL shall impose 0.5% penalty per week subject to the maximum of 5% of the Total amount.

11. Security deposit: 5% of the gross value of the work done will be deducted from the running bills as security deposit. No interest shall be payable to contractors on the amount of security deposit.

The contractor will be fully responsible for any kind of penalty levied by Central/ State Govt. or any other agency for not following the statutory rules and regulation.
