The bidder shall submit to this request for issue of tender specifications along with experience details, copy of registration with PSTCL/PWD/Irrigation/Public health/MES or any other public sector or Govt. undertaking, list of available T&P items, copy of memorandum of incorporation of company and its registration with registrar of companies, copy of EPF registration No., GST No., & PAN No. etc etc.
4. The interested contractors/Firms must submit their request for issue of Tender Specifications by 13.11.2024 till 5.00 PM along with all the eligibility documents.
5. The tender specifications shall be issued to eligible bidders by 13.11.2024. The detail of receipt & opening of tenders in this office are as given below:-

6. Tender of the contractors who do not purchase the tender documents in advance shall not be received.
7. Requests for issue of tender documents received late due to any reason including postal delays or request not carrying information/documents asked vide para 3 or request received through telex, fax shall be rejected. Conditional requests are also liable to be rejected.
8. Rates quoted in tender should be valid for 120 days.
9. Those bidders who are issued tender specifications are to submit their complete tender documents on or before the last date mentioned above along with fixed earnest money (As per tender documents). For more details on earnest money, tender documents may be referred.
10. Notwithstanding anything stated above, the competent authority reserves the right to assess the bidder's capabilities and capacity to execute the contract satisfactorily before deciding on issue of tender documents and even afterwards for deciding about awarding the work.
