2. The maintenance work shall be executed under the supervision/instructions of Engineer-Incharge only i.e. AEE/Mtc 400KV S/s, PSTCL Behman Jassa Singh.
3. Minimum Rs. 5,000/- Or @ 2% of tender value (rounded off to a multiple of Rs. 10 on higher side), through NEFT or DD in favour of ASE P&M Division Bathinda payable at Bathinda.
4. Rates should be valid for 120 Days & GST should be indicated separately.
5. The envelope containing the quotation must be super scribed with the name of tender and due date of opening of tender.
6. Quotation received after due date and time will be rejected.

14. The hydra/crane shall be provided by the firm/contractor on any day and within one hour after intimation by the Engineer Incharge.
15. The number of hours shall be counted after reaching the hydra/crane at 400KV s/s Behman Jassa Singh and up to completion of work as intimated by Engineer-Incharge.
16. The responsibility of any kind of damage/loss to the hydra/operator shall be of the contractor/firm only.
17. Number of hours of work in a day will depend upon the site requirements or as instructed by Engineer- Incharge.
18. Firm/contractor or their representative may visit the site on any working day before the date of opening of tender for any clarification/work requirements.
19. The hydra/crane should be in working condition and driver should be skilled.
