- 1) The quotation rate should be inclusive of all costs, including : Material, Labour, Transportation T & P and any additional requirements for the work of plugging the Oil Leakage in T-1 Power T/F (Capacity 220/132KV, 100MVA, Make-BHEL, YOM-1988) having heavy Oil  
Leakage from: R&Y Phase OLTC, Tertiary Bushing, Inspection Covers, Top Plate, Bolts & Thermosyphon Tank.  
Seepage from: HV side Y & B Phase Bushing Turrits & N Bushing
- 2) The quotations must reach in this office Sr. XEN, P&M Division, PSTCL Kapurthala on or before 11:00 AM on 06.03.2025. The same will be opened at 11:30AM on the same day. If this day is a holiday the quotations will be opened on next working day in the presence of suppliers (if any).
- 3) Undersigned reserves the right to cancel the above quotations without assigning any reason thereof.
- 4) If the value of the total work (including taxes) exceeds Rs 50,000/- then Earnest money @2% subject to minimum of Rs. 5000/- will be deposited in the form of DD in favour of "Sr. XEN, P&M DIVISION, PSTCL Kapurthala" payable at Kapurthala. OR Micro & Small enterprises exempted under MSMED Act 2006 read with relevant notification issued by Government of India from time to time are exempted from depositing EMD.
- 5) Quotation without EMD amount will not be considered, if applicable.
- 6) Quotation to be submitted in two separate envelopes, one envelope contain quotation and other contain earnest money. if applicable. Earnest money envelope should be named as EMD for TE.No. 03/2425 and address to Sr Xen P&M Division Kapurthala
- 7) Quantity of work can be increased or decreased as per requirement.

- 9) The rates should be firm F.O.R destination. All work related with this project will be permitted to carried out only within the premises of 220 KV Sub Station Sultanpur.

If the firm fails to complete the work in stipulated period of Work order, the same is liable to be rejected and if accepted the firm will be liable to pay as penalty charges @ 0.5% of the cost of left over work per week for the delay or thereof subject to maximum of 5% of the cost of complete unit of undelivered material.
- 11) The payment will be made within 45 days through RTGS/NEFT after submission of Invoice/ Bill once the work is completed in good condition.
- 12) The Performa for price schedule shall be duly typed and prices written by hand shall not be accepted. Any Overwriting, erasing, cutting etc. should be avoided.
- 13) GSTIN number of your firm must be quoted on your quotation & firm shall furnish self-attested, copy of valid GSTIN & PAN also. If all these documents are not provided along with quotation, the quotation will be cancelled.
- 14) Warranty period must be quoted with quoted rate subject to minimum 12 months or more and quotation without warranty period will not be acceptable. Firm is bound to attend the leakage (if starts again) free of cost in the Warranty period to whom work order will be issued.
