Sub: Accounting of non-reusable transformer oil returnable to store.

In-continuation of Account circular no. 11/2019 dated 11.10.2019 issued by PSTCL, the accounting of non-reusable transformer oil drained from the damaged transformer has been revised. Now, the non-reusable transformer oil shall be accounted for in the books at the average rate at which non-reusable transformer oil was sold in auctions conducted during the previous financial year, instead of assigning it a zero value.

The value at above mentioned average rate shall be determined by the Store Dept. at the time of accounting for the Store Return Warrant (SRW) and shall be intimated to all the concerned offices. The existing entries for accounting of non-reusable transformer oil are modified as follows:-

The remaining accounting entries/procedures regarding the sale of non-reusable transformer oil will remain the same, except the account code is to be used i.e. GH: 22.780 (Scrap O&M) instead of GH: 22.319/22.339 (Capital/O&M materials issue -others) that is to be used for useable transformer oil.
