In case of Turn Key Projects Where the original order was placed with the approval of BODs/WTD: The approving authority will be the concerned Director up to the cost of 5% of the original value of PO/WO (with P/V or without P/V) of Total cost of turnkey project irrespective of the variation in quantity. In case, the increase in total cost is more than 5% of the original value of PO/WO, the case shall be decided by BODs/WTDs as the case may be. Where the original order was placed with the approval of the authority other than BODs/WTDs: The approving authority will be the authority in whose financial power the case falls as per Delegation of Powers after considering the revised cost of tender. |
