Public Notice in respect of Petition No. 60 of 2024 filed by Punjab State Transmission Corporation Limited (PSTCL) before the Punjab State Electricity Regulatory Commission for Revised ARR Forecast and Determination of Tariff for FY 2025-26 and True up for FY 2023-24.

1. Notice is hereby given to all that the Punjab State Transmission Corporation Limited (PSTCL), engaged in electricity transmission and the functions of State Load Dispatch, has filed petition before the Punjab State Electricity Regulatory Commission, Chandigarh for approval of revised ARR forecast and determination of Tariff for Transmission Business and SLDC for FY 2025-26 and True up for FY 2023-24, under Section 62, 64 and 86 of the Electricity Act, 2003 read with Regulation 10 to 12 of PSERC (Terms and Conditions for Determination of Generation, Transmission, Wheeling and Retail Supply Tariff) Regulations, 2022 as amended from time to time. The petition has been admitted by the Hon'ble Commission vide order dated 04.12.2024 as Petition No. 60 of 2024.
