Pursuant to the judgment passed by the Hon'ble High Court in CWP No. 21012 of 2024 dated 29.08.2024, PSPCL was directed to pass a fresh order in accordance with the law and in light of the statements made by the learned counsel for the parties, after affording you a due opportunity of hearing.
