Subject:- Admitted Cases in Hon'ble High Court at Chandigarh-CWP, LPA, RSA, C.R., RFA, FAO etc.

It has been observed that admitted cases from the year 1991 onwards are being listed for hearing in the Hon'ble High court during these days. The cases are more than 20 years old and as and when the same are taken up, the counsel of erstwhile PSEB/now PSTCL often does not appear. This may be due to the reason that the counsel engaged at that time might have been elevated to the Bench or have left practice or designated as Sr. Advocate or due to some other reason. In certain cases the Hon'ble High Court issues notice but in many cases does not even issue any notice to Board / PSTCL as a consequence of which, cases are being dismissed in default as disposed of for want of prosecution as was done recently in RFA No. 1856 of 1991 (O&M) Mangal Rai (deceased) through his L.R. vs. L.A.C. and other which was decided on 20.07.2012 in the absence of Corporation Counsel. The Hon'ble High Court can also issue direction to appear in person to the Chairman-Cum-Managing Director, PSTCL. So in order to avoid such situation and to safeguard

the interest of PSTCL you are requested to check all the old admitted pending cases relating to your department and contact the advocates engaged in those cases and request them to be generally vigilant. In case the advocates engaged are not available for the aforesaid reason or otherwise then new Advocate may be got appointed from this office. ~~The~~ ^{They} have already requested to your office in the matter of monthly pending Court Cases list.

Please acknowledge and ensure proper follow up of Court Cases.
