After this stage, representation/legal notices of employees/class of employees shall be brought before this Forum by the Head of the Department concerned and after due deliberations on the case/cases, if the Forum, forms an opinion that earlier decision of the competent authority require modification/alternation to avoid litigation by employees/class of employees, it shall recommend the same to place before the WTD accordingly for decision through office represented by Convener.
