SUBJECT:- REVISION OF FEE STUCTURE OF ADVOCATES ON THE PANEL OF PSTCL.

In partial modification of PSPCL office order 19 dt. 31.05.2011 the Board of Directors of PSTCL in its 84th metting held on 10.06.2024 at PSPCL Guest House Cum Transit Camp, Chandigarh, has approved the revision of fee of advocates of PSTCL at Punjab & Haryana High Court, State Consumer Dispute Redressal Commission & other Equivalent Court at Chandigarh & District Court in Punjab & Chandigarh alongwith other Courts/Tribunals/Commissions/Forums equivalent to District Court which is as under:-

NOTE:-

1. The first half fee bill of any case allotted to an empanelled advocate should be cleared at the earliest i.e. before the next date of hearing and second half fee bill should be cleared within one month after the decision of the case and receipt of the judgment and other paper from the advocate.

2. In case any advocate on the panel of PSTCL for Chandigarh and Delhi insists fee beyond norms and raises bill accordingly can be removed from the panel after giving one/two warnings. Therefore, the advocates are being requested to prepare bills according to the norms of PSTCL.

3. No advocate on the panel of PSTCL for any court or engaged as a special case from outside the panel should make any statement in the court which may harm the interest of the Corporation without getting approval from the Competent Authority. 4. Advocates who do not take interest in the PSTCL's work and who do not attend the court on the date of hearing or do not make alternative arrangement, in case of his absence or who appears against the PSTCL shall be removed from the panel forthwith.

5. For advice cases marked to them, advocates will be paid fee as admissible for drafting.

6. For arbitration cases the advocates shall be paid as per the panel norms admissible to him as approved by the BOD's.

7. Misc. Expenses are required to be paid in all cases provided controlling officers are satisfied that same are reasonable, justified, and actual incurred by the Advocates out of their pockets or 25% of total fee (Whichever is less).

8. The revised fee norms as above shall be applicable to the cases allotted to the advocates from the date of BOD's meeting.
