	Fee for appearance & arguments	Rs. 40,000/- per hearing
3	Fee for drafting (Main Case)	Rs. 15,000/- per case + misc. Expenses
N.	Fee for connected cases	Rs. 10,000/- per case + misc. Expenses
(ii).	Fee of the Advocates-on-Record	
	Fee for appearance & arguments	Rs. 35,000/- per hearing
	Fee for drafting (Main Case)	Rs. 15,000/- per case + misc. Expenses
	Fee for connected cases	Rs. 10,000/- per case + misc. Expenses

The advocates not on the panel of PSTCL shall be engaged at the rate decided with the approval of CMD, PSTCL. Note:-

1. The other terms are conditions are same as mentioned in office order no. 11/LB-3(14) Counsel Fee Norms dt. 08.07.2024.

2. Misc. expenses are required to be paid as per office order no. 84 dt. 02.09.2003 in all cases provided controlling officers are satisfied that same are reasonable, justified and actual incurred by the advocates out of their pockets or 25% of the total fee for appearance and arguments, whichever is lower.

3. The revised fee norms as above shall be applicable to the cases allotted to the advocates on or after the date of BOD's meeting.
