Erection of new 66 kV bay at 220 kV S/s Dhuri (Kaheru) may done as per the MoM held on 24.11.2023 and 28.07.2023. 3. Estimated cost has been considered as informed by Sr.Xen /Grid Construction Division, Patiala vide his office Memo No.1174/76 dated 23.04.2024 and Sr. XEN/ Civil Works Division, PSTCL, Patiala vide his office Memo no.976 dated 05.04.2024. 4.
