Coffee is traditionally grown in Karnataka, Kerala, and Tamil Nadu in India. It is predominantly an export-oriented commodity and 65% to 70% of the coffee produced in the country is exported, while the rest is consumed within the country. In the international market, Indian Robusta is highly preferred for its good blending quality. Arabica coffee from India is also well received in the international market. Coffee is an export product with low import intensity and high employment content. This is evident from the fact that more than six lakh persons are directly employed and an equal number of individuals get indirect employment from this sector. Arabica is a mild coffee, but the beans are more aromatic; it has a higher market value compared to Robusta beans. On the other hand, Robusta has more strength and is therefore used in making various blends. Arabica is grown in higher altitudes than Robusta. The cool and equable temperature, ranging between 15°C and 25°C, is suitable for Arabica, while for Robusta, a hot and humid climate with temperatures ranging from 20°C to 30°C is suitable. Arabica requires more care and nurture and is more suitable for large holdings, whereas Robusta is suitable irrespective of the size of the farm. Arabica is susceptible to pests and diseases such as White Stem Borer, and leaf rust, and requires more shade than Robusta. The harvest of Arabica takes place between November and January, while for Robusta, it is from December to February. (10)

The chief object of the repetitive form of advertisement is to help people to remember the product. The general principle is similar to that followed by Bajaj Automotives Ltd: "You just can't beat a bajaj". The repetition of a phrase, the inclusion of a trade name or a trade mark in every advertisement is intended to impress upon the mind of the reader or listener that name or phrase or picture. The response sought by the advertiser is achieved when a customer enters a shop for, say, toothpaste. To the shop-keeper's question, "any particular brand, please?, the customer gives the reply that is in his mind, not necessarily because he has arrived at a decision by any process of reasoning, nor because some strong feeling has been aroused for some particular brand, but simply because he has repeatedly seen the name, and it is associated in his mind with the idea of a good toothpaste. Some trade names become so common that they displace the true name of the commodity itself, such as 'vaseline', the well-known trade name for 'petroleum jelly'. Advertisements which have relied on repetition have, in the past, proved very powerful, but with the increased variety of proprietary articles and products intended for the same purpose, this kind of advertising is losing some of its value because of the confusion of names that arise in a customer's mind when he wishes to buy, say,

cigarettes, tobacco, soap, chocolates, tea and other goods which are widely used.

AMENDMENT OF PURCHASE ORDER/CONTRACTS All amendments, before issuance, shall invariably be got pre-audited by the purchasing agency from an officer of the Accounts organization, not below the rank of Accounts Officer and by Divisional Accountant where PO has been placed by Division.

- 30.1 Amendments involving additional Financial Liability
- 30.1.1 The authority deciding the original tender enquiry may allow purchase of additional quantity upto 10% of the Purchase Order Quantity in emergent cases at tendered rates provided that the overall powers, after acceptance of enhanced quantity, does not exceed as per clause 12 of these regulations.
- 30.1.2 For other amendments involving additional financial commitment on account of price variation, increased taxes/statutory levies etc. due to extension in due date of delivery, provided the delay is genuine, the approval of authority, which originally decided the tender enquiry, shall be obtained.
- 30.1.3 Such cases shall invariably be got pre-audited from the concerned Accounts Officer. The proposal as well as orders for extension in delivery period shall be quantified and well-reasoned.
- 30.1.4 In case the order was placed with the approval of Board/WTDs, then the cases shall be approved by the Director/Technical & Director/F&C.
- 30.1.5 For amendments involving additional financial liability where overall power of the authority which decided the tender enquiry is exceeded, approval of next higher authority will be obtained.
- 30.1.6 In case there is a change in quantity then upto (+ or -) 2% of the quantity can be accepted by the purchasing agency without making any amendment in the P.O.

As the number of business transactions increases, it is difficult to manage accounts manually, as it takes a lot of time to update a single transaction in all the accounts that it affects. In computerized accounting, a number of limitations of the manual accounting have been removed. Whenever the transactions occur, the entry is made and it is updated automatically in all the accounts that it affects, in the computerized accounting.

b) DOS stands for Disk Operating System. It provides a file system that allows you to read, write, and arrange files on the disc storage. In essence, it is an operating system for a single user. To ensure the system is functioning properly, it carries out a number of tasks. It allocates resources, controls hardware devices, handles files, permits program loading and execution, and loads and runs programs. A GUI is not available in DOS (Graphical User Interface). It offers a command line-style user interface. The commands entered by the user on the command line are interpreted to carry out the required task. Among the commands it contains are PRINT, DEL, ERASE, and COPY. External commands are the name given to the additional DOS command kinds. They do not get much use. When required, these DOS instructions are loaded into memory.

Microsoft Cooperation created and developed the operating system known as Windows. One of the most widely used operating systems worldwide. The success of Windows can be attributed to its graphical user interface. Users can rapidly access applications thanks to it. Various iterations of Microsoft Windows are still in use today. Windows XP, Windows Vista, Windows 95, Windows 7, 8, and Windows 10 are a few of them.

Here, we have provided the key differences between DOS and Windows.

- The graphical user interface, or the graphical interface, is where DOS and Windows differ. Windows employs a graphical interface with graphics, icons, and text while DOS uses full-text command input (and that too without a mouse).
- Windows is an intuitive operating system (interface). Unlike DOS, which has a text-based user interface.
- Windows outperforms DOS in terms of storage by providing 2
 Terabytes of memory, which is equivalent to 2000 gigabytes of memory, for today's generational needs.

 Windows allows multi-tasking, multi-programming, and multi-user systems, whereas DOS only supports single-tasking, a single-user environment, and single programming.

 DOS allows the use of the keyboard as the primary input, whereas Windows allows the use of both the keyboard and mouse.

- i. **Num Lock**: They allow users to input numerical values into a computer or other device and can also be used for other functions such as navigating through menus and entering special characters when combined with the Shift or Alt keys.
- ii. **Scroll lock** allows you to navigate any document using the arrow keys without accidentally moving or scrolling through the page.
- iii. **Caps lock** is a key on your computer keyboard that, when pressed, changes the case of the letters you type. When caps lock is activated, all letters you type will be in uppercase, regardless of whether you press the shift key or not.
- iv. **PrtScn:** To capture the entire desktop screen at once, simply tap the 'PrtScn' key which copies the screenshot to your clipboard, ready for pasting into different software. With 'Windows Key + PrtScn' you have added functionality; this will save a file and create an image stored in your computer's Pictures folder.
- v. **Insert Key:** When you press the insert key, it changes the input mode from typing mode to overwrite mode and vice versa. In typing mode, all of the characters you type will appear after the cursor while any existing text will stay in its place and move down if needed to make room for your additional text. There are a few different ways that the Insert key can be used, depending on the program you're using.

- 1. **The OMR** reads the special mark made by pen or pencil, OMR focuses light on the page and detects the mark. OMR is also the process of reading information that people mark on surveys, tests, and other paper documents. OMR scanner is a hardware device/machine it has an optical device which is used to scan OMR sheets. The OMR scanner throws a light onto the filled form, the scanner then detects the contrasting areas of the light at certain positions on the form, some portion of the OMR detects black marks because less light is reflected from the area due to the filled area and unfilled area fully reflect the light, the contacting colors help to detects the answer filled by the participants. In the initial days, it was mandatory to use OMR scanners as OMR technology was not highly developed but now with the emergence of OMR software, dependency on bulky scanners is not necessary.
