A) Instructions for the participants, their controlling officers & respective DDOs:-

- 1) In case of non-compliance of this office order, the responsibility will lie on the concerned deputed employee and controlling officer and strict action will be taken against them.
- 2) Request for Change in batch shall be entertained only after recommendations of concerned Dy.CE/SE, to be received in this office at least one week before the commencement of each batch. The request for change shall be sent with a substitute from another batch by mutual consent and will be considered for approval by Chief Engineer/HIS&D,PSTCL.
- 3) Participants will ensure to mark their attendance daily on the attendance sheet at the program venue, failing which charges of the program will be recovered from them besides taking any other action as deemed fit.
- 4) During the above period, the participants will be considered on duty for the purpose of pay and other allowances.
- 5) The participants will be entitled to claim Travelling Allowances as per PSEB TA Regulations-1972 (as adopted and amended from time to time by PSTCL).
- 6) Their TA/DA Charges shall be as per TA regulations. The expenses so incurred will be charged to concerned DDO while reimbursing their TA Bill. Their TA claims shall be allowed by their controlling authority/ Accounts Section only after they certify (alongwith no. and date) that the requisite Training Report has been submitted to Dy.CE/Admn. & HR, PSTCL,Patiala.
- 7) The participants will not be allowed any joining time except for the time required for attending the programme.
- 8) The participants will submit proper Training Report of the programme alongwith documents which have been given to them by Institute, mentioning their Employee Code/ Posting Station, within 7 days of completion of training, to this office. They will also intimate their

- respective DDOs regarding their participation in the Programme who will make necessary entries in their service record in this regard.
- 9) Stay arrangement will be made in Hostel as per PSPCL training policy for residential trainees.
 - 10) Only Lunch and 2 times tea and snacks will be served for Non-residential Trainees.
 - 11) The Trainees have to visit Educational Tour during training period at their own expenditure and they will claim normal TA/DA at their offices as per TA Regulations as per their entitlement.


B) Terms and Conditions for this Training Program:-


