1. "A" Class Electrical Contract Certificate from CEI Punjab.
2. PAN CARD.
3. EPF Registration Certificate.
4. ESI Registration Certificate.
5. GST Registration Certificate.
6. Affidavit regarding Non-Defaulter of EPF, ESI, GST& Service Tax of last five years (or as applicable) & regarding non-Blacklisting/debarred of the firm by any Govt./Semi Govt./PSU of India duly attested by Executive Magistrate.
7. A bank solvency certificate of an amount not less than Rs 15 lacs issued after 01.04.2024.
8. The bidder as a prime contractor should have executed the work of laying of stubs, erection of towers, Stringing, and sagging of at least a total of 20 Km. route length of 132/220 KV or higher rating of transmission lines. A necessary certificate from the concerned office not below the rank of Executive Engineer is required to be submitted by the firm.
9. Form 26 AS of the firm for the corresponding years of experience.
10. Duly audited Annual Financial Reports /Average Annual Turnover equal to Rs. 60 lacs in the last three years certified by a Chartered Accountant along with UDIN number.
11. Income Tax Returns of the firm as well as Directors/ Partners/ proprietors of the firm for the last 3 years.
12. Undertaking from the bidder that in case of award of contract to them, they shall furnish Labour License issued from Labour Department or undertaking regarding exemption of labour licence.
13. Undertaking regarding Registration Under Building and Other Construction Worker Act 1996 under Sections 7& 12.
